## FAUNTLEROY CHILDREN'S CENTER CELEBRATES 25 YEARS !

A quarter century has passed since the Fauntleroy Children's Center opened its doors. This milestone provides an opportune time to say “Thanks!” to the many residents who have encouraged us over the years and to tell new residents a bit about our history and program.

In 1977, several members of Fauntleroy Church formed the Fauntleroy Community Service Agency (FCSA), a private, non-profit corporation to address the growing need for high-quality childcare in the neighborhood.

Originally housed in the church and called the Fauntleroy Day Care Center, we opened in September 1978 with 15 preschool-aged children. By June 1981 when Fauntleroy School closed, we had doubled in size and needed more space. FCSA negotiated a lease to move the center into the north wing of the schoolhouse, where we are today. Along with changing our address, we changed our name to the Fauntleroy Children's Center.

Since then, we expanded to serve children from infants to school age, added “Kindergarten Readiness Through the Arts” (a half-day option for preschoolers), and became the only childcare program in West Seattle to earn accreditation from the National Academy of Early Childhood Programs.

The more than 100 youngsters currently enrolled include many children of former students. And we

recently welcomed the first grandchild of an alumna!

Still, I didn't figure I could get much more from the actual meeting, so I was even more querulous by the time I found a parking space near the schoolhouse. What a pleasant surprise awaited me! The FCA Board members and others at the meeting couldn't have been nicer. They even had me listed on the agenda as a guest from Alki. Bruce Butterfield ran a tight meeting and I got some ideas for improving the way we run ours.

Subsequent to the meeting, I have continued contact with Lynn Olson and have had useful exchanges with Bruce Butterfield, Judy Pickens, Gary Dawson and Lynn Sealey. The community of Fauntleroy is fortunate indeed to have such a dedicated and talented group at work. Our two neighborhoods and their issues are different, but similar in many ways, so I hope to continue our contact. Thanks for the warm welcome and useful advice.

## LOW SALMON RETURN PROMPTS HABITAT STRATEGY

For the second year in a row, the number of coho returning to Fauntleroy Creek was disappointing, especially for our 33 faithful salmon watchers. They counted just four fish, two of which apparently spawned.

Returns were also way down in other Seattle creeks but abundant in rural areas. Theories about why have been floated but the bottomline here is that, unlike prior years, we never saw coho schooling in the cove. Like prior years, though, we always learn from whatever return we have.

In consultation with agency specialists, we chose to concentrate for at least the next year on learning more about the creek as rearing habitat.

"We have no control over the ocean conditions that can make or break our salmon return," noted Tom Linde, "but we do have some control over what this creek produces. That seems like the place to focus."

Again this spring, he and Steev Ward will trap everything that leaves the creek, giving us two years worth of data about smolts leaving on time and any smaller coho leaving early.

Seattle Public Utilities has asked teachers to time salmon releases for maximum survival of fry in the wild. Also expect to hear more about water quality as we work with city and state agencies to monitor chemicals affecting salmon habitat.

Work continues in our efforts to address the traffic problems in our neighborhood. Our current emphasis is working with the traffic planning department to find viable options for making it safer to cross Fauntleroy Way in the area of the playing fields and wading pool. Megan Hoyt (SDOT) is

This little booklet, "Who to Call For Help...", prepared by the City of Seattle Department of Neighborhoods, is available at your Neighborhood Service Center. Its purpose is to direct you to the city agency that can help you solve your problem. While its primary focus is on citizen safety, it will also refer you to the city departments and services that can help you deal with a range of "Most Common Citizen Concerns," alphabetically from **A**bandoned Vehicles to **V**icious Animals.

The function and responsibilities of each city agency are described, as are the most common concerns handled by that agency. Complaint line, general information telephone numbers, and website addresses, are provided in an easily accessible format. Emergency and non-emergency telephone numbers are clearly indicated. There is even a section entitled "What if the City is the problem?" describing the Citizens Service Bureau. 
