Make Your Voice Heard: Protect Fauntleroy from the One Seattle Plan

The proposed changes under the One Seattle Plan could fundamentally alter the unique character of Fauntleroy—the community we all love and call home. These changes, including increased building heights and reduced protections for green spaces, threaten to transform our neighborhood in ways that could lead to overcrowding, loss of green areas, and diminished livability.

We need your help to make sure our voices are heard by **December 20, 2024!**

What Can You Do? We need at least **1,000 residents** of Fauntleroy to take action by sending letters to the Seattle City Council, Mayor Bruce Harrell, and the One Seattle Plan team. Together, we can express our dissatisfaction and demand thoughtful development that preserves the character and livability of Fauntleroy.

How to Take Action:

1. **Write to the Seattle City Council:** Share your concerns and request that they oppose the One Seattle Plan in Fauntleroy.
2. **Contact Mayor Bruce Harrell:** Let him know how the proposed changes would harm our neighborhood.
3. **Comment on the One Seattle Plan Website:** Use the interactive map to voice your opposition to the zoning changes in Fauntleroy.
